



Website Privacy Policy

This website is operated by LSI Projects Limited. We take your privacy very seriously therefore we urge you to read this policy very carefully as it details important information about us and:

- The personal information we collect about you, our users
- What we do with your information, and
- Who your information may be shared with

Who we are

LSI Projects Limited ('we' or 'us') are a 'data controller' for the purposes of the Data Protection Act 1998, (i.e. we are responsible for, and control the processing of, your personal information).

Information we collect

a) Personal information you provide to us

We collect the following personal information that you provide to us:

- * Name
- * Email address
- * Phone number

Some examples of when we collect this information include:

- * When registering for an account
- * When making purchases

b) Personal information provided by third parties

We may receive information about you from other sources. This information may include:

- * Credit Information - Credit References from credit agencies

We will add this information to the information we hold about you for the following purposes:

- * To check customer credit worthiness
- * To check for possible fraudulent activity
- * To improve and personalise our services

Information we collect

c) Personal information you provide about third parties

If you give us information about another person, you confirm that the other person has appointed you to act on their behalf and agreed that you:

- * Shall consent on their behalf to the processing of their personal data;
- * Shall receive any data protection notices on their behalf; and
- * Shall consent on their behalf to the transfer of their personal data abroad.

d) Monitoring and recording communications

We may monitor communications such as emails and telephone calls for the following purposes:

- * Quality assurance
- * Training
- * Fraud prevention
- * Compliance

e) Cookies and similar technologies

A cookie is a small text file which is placed onto your computer or electronic device when you access our website. Similar technologies include web beacons, action tags, local shared objects ('flash cookies') and single-pixel gifs. Such technologies can be used to track users' actions and activities, and to store information about them. We use these cookies and/or similar technologies on this website.

For example we may use cookies to monitor and/or collect the following information:

- * How many times a user visits the website
- * Which pages user visits, traffic data, location of data traffic

This information helps us to build a profile of our users. Some of this information may be aggregated or statistical, which means that we will not be able to identify you individually.

You can set your browser not to accept cookies and the websites below tell you how to remove cookies from your browser. However, some of our website features may not function as a result.

How we use the information we collect

We collect information about our users for the following purposes:

Identify you and manage any accounts you hold with us; process your order; conduct research; statistical analysis and behavioural analysis; carry out customer profiling.

Who your information may be shared with

We may share your information with Law enforcement agencies in connection with any investigation to help prevent unlawful activity

Marketing

We would like to send you information about products, services, offers and our business which may be of interest to you. Such information could be sent by post, email, telephone, text message or automated call.

We will ask whether you would like us to send you marketing messages on the first occasion that you provide any relevant contact information (i.e. on purchase, signing up to a newsletter, entering a competition etc). If you do opt in to receive such marketing from us you can opt out at any time (see 'What rights do you have?' below for further information). If you have any queries about how to opt out, or if you are receiving messages you do not want you can contact us using the details provided below.

Keeping your information secure

We will use technological and organisation measures to keep your information secure.

However, while we will use all reasonable efforts to secure your personal data, in using the site you acknowledge that the use of the internet is not entirely secure and for this reason we cannot guarantee the security or integrity of any personal data that are transferred from you or to you via the internet. If you have any particular concerns about your information, please contact us using the details below.

What rights do you have?

Right to request a copy of your information

You can request a copy of your information which we hold (this is known as a subject access request). If you would like a copy of some or it, please:

- * Email, call or write to us (using the contact details below)
- * Let us have proof of your identity and address (a copy of your driving licence or passport and a recent utility or credit card bill), and
- * Let us know the information you want a copy of, including any account or reference numbers, if you have them

We may ask you to pay a fee before sending this information to you.

What rights do you have?

Right to correct any mistakes in your information

You can require us to correct any mistakes in your information which we hold free of charge. If you would like to do this, please:

- * Contact us using the contact details below
- * Let us have enough information to identify you (e.g. account number, user name, registration details), and
- * let us know the information that is incorrect and what it should be replaced with

Right to ask us to stop contacting you with direct marketing

You can ask us to stop contacting you for direct marketing purposes. If you would like to do this, please:

- * Email, call or write to us (using the contact details below)
- * Let us have proof of your identity and address (a copy of your driving licence or passport and a recent utility or credit card bill), and
- * Let us know what method of contact you are not happy with if you are unhappy with certain ways of contacting you only (for example, you may be happy for us to contact you by email but not by telephone)

From time to time we may also have other methods to unsubscribe from any direct marketing including for example, unsubscribe buttons or web links. If such are offered, please note that there may be some period after selecting to unsubscribe in which marketing may still be received while your request is being processed.
